Dear Parents/Guardians,

Supplemental guidelines clarifying expectations regarding full time remote learning options for families were issued for the “The Road Back” on Friday, July 24, 2020.

Based on this new guidance **all students are eligible for full time remote learning**; eligibility cannot be conditioned on a family/guardian demonstrating a risk of illness or other selective criteria.

Katzenbach will offer the following:

- 5 full days in person instruction at Katzenbach
- 5 full or 4-hour minimum remote virtual instruction.
- We will not offer a hybrid program
- There will not be an Extended Day Program.
- There will not be a Residential Program for the first marking period. We will evaluate at the end of the first marking period.
- September 9th and 10th will be a staggered opening for in-person instruction.

***On September 9th and 10th - In person instruction students who are not scheduled to come to Katzenbach will have virtual instruction.**

September 11- All in-person students/grades at Katzenbach

- For students whose parents have chosen virtual/remote, classes will begin virtually on September 9, 2020.
- September 9th to September 18th will be early dismissal days ending at 1:00 PM. Students will eat lunch in school.
- Full day in person will begin on September 21, 2020.

Remote Learning

- Attendance policies must be followed.
- A minimum of 4 hours of instruction is required. (exception pre-school)
- **Katzenbach Procedures**
- Parents/guardians must submit a request for beginning the school year with fulltime remote learning.

This request must be submitted in writing by **Friday, July 31, 2020** and e-mailed to joan.krasnisky@mkasd.org

- Parents/guardians who wish for their child to begin school with in person instruction **do not** need to submit a request.
- If you choose remote learning, and would like at a later date to move your child to in-person at Katzenbach, you will need to submit a request to your child's **principal** in writing a **minimum of two weeks** before your child's return date for in-person instruction at Katzenbach.
- If your receiving in-person instruction at Katzenbach, and you want your child to receive remote instruction at home, you will need to submit a request to your child's **principal** in writing a minimum of **four weeks before the end of the marking period.**
